Individual Authorization Agreement To Hiway

Rights and Obligations to Authorizing Matters

- 1. I hereby grant Beijing Zhongjia Hiway Sci.&Tech. Ltd., Co.(hereinafter referred to as Hiway) the *Information Network Transmission Right* of information resources (i.e. Works) whose copyright belongs to the author. - 4. Should the authorization be effective, this formal consent is irrevocable.
- 5. Should these information resources under this authorization agreement are pirated or/and distributed through internet unlawfully, rights to curb the misdeed are reserved by Hiway.

Breach of Responsibility

- 1. Either Hiway or the author can not infringe the authorization agreement, or the violator must be responsible to compensate for the loss of the other that is due.
- 2. Infringement not included in this agreement is punished according to the laws and regulations of PRC.

OTHERS

- 1. Should the need to reshape the inside operation appear, Hiway is permitted to transfer the *Information Network Transmission Right* to companies that is related to these business by way of written notice or bulletin.
- 2. The Agreement shall come to effect upon the signing date with the validity of twenty years. Within the expiration of three months, the agreement shall be automatically postponed with the permission of both the author and Hiway. If not, the objection must be in way of written form.
- 3. Should Matters not covered or objections exist in this Agreement, debate is allowed between the author and Hiway so that the additional provisions of this agreement can be signed. Or it can be submitted to Beijing Arbitration
